7.0 COMMUNICATIONS

7.1 HR Update

Director of HR Kin Shuman informed the board that in November of 2020, Colorado voters approved Proposition 118, which paved the way for a state run paid leave insurance program. The FAMLI program would enable Colorado workers to have access to paid leave in order to care for themselves or members of their family during life circumstances that take them away from their jobs. However for Elizabeth Schools, participation in the program would result in costly and unnecessarily duplicative insurance for most employees since Elizabeth Schools already offers discretionary (sick and personal) leave to all regular employees, allows employees to accumulate leave time across fiscal years, operates sick leave banks for employee groups, and complies with the federal Family and Medical Leave Act. The board's approval to opt out will not prevent individual employees from participating in FAMLI on their own, if they choose. District administration is recommending approval of the attached resolution declining employer participation in Colorado's Family and Medical Leave Insurance program.

7.2 Technology Update

Director of Technology Marty Silva spoke to the board about technology updates the team is going to focus on while staff and students are out on winter break. It allows the technology department to push updates without impeding access during in class time. Additionally, there is a tech committee that is compiled of teachers from the schools who help advice the technology department on the hands-on, in the classroom updates to help guide future focuses for the technology department. The committee meets seven to eight times a school year and has been instrumental in serving as the eyes and ears for classroom success and struggles around technology.

7.3 Financial Update

Chief Financial Director Ron Patera reviewed checks over \$5,000 which includes typical monthly expenses such as utility bills, charter school flow thru and insurance premiums. There were also payments for: numerous tech expenses, SPED facility costs, SPED contractors, SRO payment, playground equipment, modular payment, outdoor ed., and pump replacements for fire and irrigation at SHE. The financial statements activity through the end of August or 16.67% through the new fiscal year, general fund revenues are at 15.27 collected year to date, while expenditures are 16.12% spent when compared to the budget. Even though there are some cost centers over the 16.67% benchmark and overall, some of these are due to large one time expenditures, expenses that are payables that will be reflected in last year's financial statements or beginning of the year classroom startup expenses. Looking at the overall spending within the general fund there is nothing in here that I am too concerned about now. Enrollment is currently budgeted up 34 students from last school year. The unofficial number puts us up an additional 21 students from our projection; this excludes Legacy, for a total increase of 55 students. My best estimate is an increase in funding of around \$220,000K. The increase is not higher due to 5 year averaging, but it is still to our advantage because we are being funded at a higher number than our actual enrollment.

Interim Superintendent William Dallas provided an update to the board on the upcoming national recognitions for the month of October. National Safe Schools Week and National School Bus Safety Week is October 17 – 21st and Red Ribbon Week is October 23 – 31st.
