Staff requests approval of the following:

A change to daily pay rates for substitute teachers for the 2022-2023 school year. The rates requested are as follows:

The current rates were temporarily established in order to address a serious sub teacher shortage during the COVID outbreak. The proposed daily rates have been reduced by \$50 per day, however the proposed rates are higher than the pre COVID rates and the base rate of \$150 per day matches the daily rate at Douglas County Schools, our primary competitor for substitute teachers.
