## 7.0 EDUCATION SHOWCASE

7.1 Elizabeth High School Showcase

Elizabeth High School Principal Bret McClendon shared highlights from the school year with the Board of Education.

The third annual Big Help Community Service Day, sponsored by EHS Student Council, took place on April 25. This is the second year that the entire school participated and the first year that Frontier High School students also participated. The students volunteered at more than 20 locations throughout the community.

National Honor Society students hosted a schoolwide Wish Week to raise money to grant the wish of a 7-year-old with Cerebral Palsy who requested a service dog. This is the first time NHS has taken on a schoolwide project.

The ASPIRE (Adult Students Preparing for Independence Responsibility and Employment) program led by Anne DeWeese was launched this school year. The program helps 18 to 21-year-old students who have significant needs become self-sufficient. Currently, 4 students are in the program with more expected next year. Principal McClendon said he hasn't seen a program have more impact on kids than ASPIRE.

Leanne Cook has taken on a career prep specialist role this year at EHS and she's done a tremendous job getting students to visit colleges. She organized the college fair in March that brought in more than 40 colleges and technical schools. The fair was very well attended and received great feedback. Principal McClendon plans to expand the school's college and career readiness efforts.

Principal McClendon has been visiting with other schools to explore partnerships that could provide students with learning options that aren't currently available or the school is not able to provide, such as agricultural and auto programs. Any partnership would most likely require a change in EHS' current bell schedule.

EHS counseling facilitated a survey recently with 83% of staff and 80% of students responding. The survey indicates there are some issues with how individuals treat one another that need to be tackled and the school will involve students in the solution. Here are a few takeaways from the survey:

- 46% of staff and 52% of students think classmates are accepting of one another
- 80% of staff said they understand what life is like outside of school for students while 76% of students said staff does not understand what life is like for them outside of school
- 74% of staff feel school administration conveys expectations
- 91% of staff think school administration respects students
- 50% of students believe they and their peers care about learning
- 51% of students said they and their peers treat each other with respect
- 93% of students feel safe at school



 There were similarities between staff and students response to top 15 things to work on, which included time management, study skills, and anxiety/depression

Superintendent Bissonette shared the second semester Class Size Report. The district's situation is very good in terms of teacher-to-student ratios. The biggest area that stands out is that SHE had two grade levels that had higher than desired class sizes – 28 kids each. In third grade, one class had 24. Had aides to help in some of the classes with higher than desired ratios.
