10.0 DISCUSSION ITEMS

10.1 Candidate Meet & Greet

The board continued discussions about hosting a meet and greet with the four board of education candidates. The board decided not to hold a candidate meet and greet due to the time involved and the low turnout at previous events. Candidate information will instead be included on the district website and shared through the district's communication channels.

10.2 Legislation re PERA Reform Recommendations

Superintendent Bissonette shared the Colorado Public Employees' Retirement Associations' (PERA) Board of Trustees recommended changes that are an attempt to resolve the problem of PERA's unfunded liability and the amount of time it will take for PERA to be fully funded. The reforms suggested by PERA include (Any changes to PERA require legislation approved by the Colorado General Assembly.):

- Reduce the Cost of Living Adjustment (COLA) to current retirees from 2 percent to 1.5 percent
- Move the age of retirement for PERA employees hired after 2020 to 65 years old.
- Change the number of years to calculate retirement benefits for new PERA employees hired after 2020 or any PERA employee with less than five years of credited service.



- Employees' contribution would increase 3 percent for PERA members hired before 2020 (Employees hired after 2020 would contribute an additional 2 percent)
- Employer contributions would increase an additional 2 percent. (The total for school districts would be 22.15 percent.)
- Change the definition of PERA-includable salary to require PERA to collect contributions on gross salary including IRS Section 125 and 132 deductions.

The Elizabeth Schools board will revisit the discussion about the PERA recommended changes following the Colorado Association of School Board's Fall Delegate Assembly Conference.
