The Elizabeth School Board of Education met this past Monday, October22; here are the highlights.

Cardinal Homecoming

Congratulations to the EHS Cardinal Football team on the big win at last Friday night's homecoming game. Last week was Cardinal Week, filled with activities for the entire district including spirit days, bonfire, parade, tailgate party, and the homecoming game followed by spectacular fireworks. The Cardinal Week is a tradition unique to the Elizabeth Schools in that many school districts do not have this level of activities to celebrate homecoming. We extend our appreciation to the Student Council, our students and staff, the parents, and our partners in the community for supporting our Cardinal Week tradition.

Superintendent Update

The Elizabeth School District enrollment, PreK-12, **increased by 48 students**, from 2,656 last year, to 2,704 for 2012-2013 school year. The count includes Legacy Charter School. Excluding the enrollment at Legacy, Elizabeth Schools increased by 33 students. This is encouraging and reflects the ongoing efforts in improving the Elizabeth Schools and the support from our district community.

The school district and Elbert County are working together to coordinate the use of Elizabeth High School and Singing Hills Elementary as voting locations for the **November 6 General Election**. Yesterday, an email communication, sent to all parents and guardians, explained these coordinated efforts and outlined logistic information for Election Day. Signs indicating traffic flow, voter parking, and voter entrance to the schools will be posted on Election Day. Maps of SHE and EHS indicating this information are also available.
