Tim Dore, State Representative addressed the Board of Education at the meeting. He encouraged the districts feedback on legislative issues centered around funding and accountability. Tim Dore acknowledged the importance of a good working relationship with school districts and plans to visit Elizabeth Schools again to provide periodic updates.

Andrea Duran, Director of Learning Services, received Employee Recognition for her good work in support of our Special Education (SPED) students, their families, and our staff over the last year and a half.
